I agree to deliver the artwork to the center on Friday, May 30, 2025, 1-5PM. and pick up the unsold artwork on Friday, September 12, 2025, 1-5PM. Neither Lyric Works nor Houston Visual Artist Network will store artwork. It will be disposed after the end of the exhibition period if not removed by the artist or artist's representative.

There is no installation/entry fee charge with paid membership to Houston Visual Artist Network. All members are expected to serve volunteer hours.

The curator or any of his/her assistants have my permission to install the artwork and take it down. As sole owner of my original artwork, I am responsible for insurance of artwork. I will not hold Houston Visual

Artist Network nor Lyric Works responsible for the handling or security of this artwork.

I am aware that I will be notified of my acceptance via email by Monday May 26 , 2025.
